GIVE TO LINCOLN DAY IS MAY 26

\$300,000 Challenge Match Fund offered for Nonprofits

Give To Lincoln Day returns for a 5th year on Thursday, May 26. People are encouraged to make a charitable donation to local nonprofits they care about during this 24-hour day of giving.

The Lincoln Community Foundation and their sponsors will contribute a match fund of \$300,000 for Give To Lincoln Day. Every nonprofit organization will receive a proportional share of this fund, based upon their percentage of the total dollars raised on May 26. The match fund increases every donation made on Give To Lincoln Day, making every gift even more meaningful.

LAST YEAR, GIVE TO LINCOLN DAY RAISED \$3.2 MILLION

“Give To Lincoln Day was an outstanding success last year, helping to support 327 of Lincoln’s nonprofit organizations,” said Barbara Bartle, President of Lincoln Community Foundation. “This community-wide event has become a citywide celebration that contributes significantly to the quality of life we enjoy in Lincoln. By helping nonprofits raise funds, this one day event helps them carry out their important work.”

Give To Lincoln Day aims to encourage philanthropy and meet the community’s growing needs. It increases public awareness of local nonprofit organizations, helping the agencies tell their stories and attract new donors.

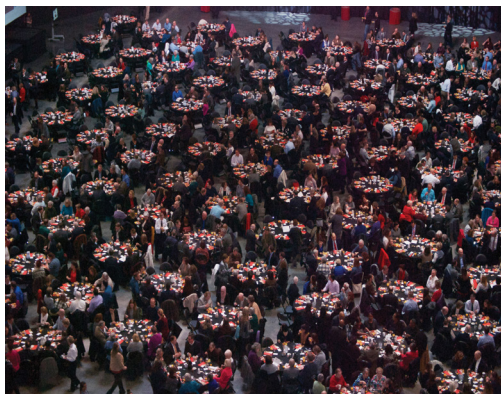
Donations to participating nonprofits may be made online beginning at 12:00 a.m. on May 26 and ending at 11:59 p.m. Starting on May 1, there is also an online feature that allows you to schedule your donations in advance, to be counted for Give To Lincoln Day and the match fund. The minimum donation is \$10. The Lincoln Community Foundation will also receive donations from people who prefer to make their gifts in person at the Foundation office between the hours of 8:00 a.m. and 5:00 p.m. on May 26.

Open a donor advised fund and schedule your Give To Lincoln Day gifts right now through Lincoln Community Foundation. The Foundation does not charge any fees for gifts made from your donor advised fund so your selected nonprofits receive 100% of your donation. Call us to learn more or to open a fund.

Prosper Lincoln is bringing together every sector of our community to make our city even better. On February 10, more than 1,000 people attended the Prosper Lincoln Summit at Pinnacle Bank Arena. The crowd was challenged to become involved and to make personal and organizational commitments to support three priority areas of the Prosper Lincoln community agenda.

Early Childhood Education. The goal is to help all children, regardless of their background, learn and grow during their early years. According to Lincoln school officials 700 children are on a waiting list to attend LPS early childhood programs and one goal is to ensure every child has a space to attend a program by 2020.

Employment Skills. The goal is to have a workforce with the talent to meet the



increasing demand from employers for stronger knowledge and capability skill sets. Enhancing job skills will result in more employment opportunities, which can help reduce poverty levels while promoting higher wages and better benefits for local workers.

Innovation. Lincoln strives to be a city of innovation for all sectors, from cradle to grave, which will make things better for residents

throughout the community. Prosper Lincoln’s goal is to create a culture of innovation that can be passed on from one generation to the next.

These three priority areas, and their goals and objectives, were shaped from 2,105 ideas submitted by community members and then narrowed and developed into a community agenda by more than 100 citizens from every corner of the city. The next step is to engage people across all sectors – businesses, anchor institutions, nonprofit organizations, neighborhoods, government, faith communities, philanthropies and individuals – to implement the agenda and successfully reach the goals by 2020. With this accomplishment, all in the community will truly prosper.

An infrastructure has been put in place to coordinate action and sustain the work over the next four years.

The three priority areas are under the umbrella of this infrastructure:

JIM AND MARY ABEL & THE ABEL FAMILY TO BE HONORED WITH CHARITY AWARD

The Lincoln Community Foundation is pleased to present Jim and Mary Abel, and the Abel family, with the 2016 Charity Award for three generations of leadership and philanthropic work in Lincoln and throughout the state. They will be recognized at the Foundation’s annual Donor Recognition celebration on May 5.

“Mary and I were exposed to philanthropy by the generations before us,” said Jim Abel. “We both had parents, grandparents and relatives who were passionate about being charitable, doing good for others and being involved in their communities.”

In 1931, George Abel Sr. and Hazel Abel made the first significant community gift, all the brick and concrete needed to help First Plymouth Congregational Church move to 20th and D Streets. For decades, the Abel family and the Abel Foundation have made substantial gifts to fund a wide variety of projects and organizations including the University of Nebraska Foundation, Abel Hall, College of Business Administration, YMCA, Hazel Abel Park, Mahoney State Park, The Nature Conservancy and the Alice Abel Arboretum and Abel Stadium at Wesleyan University.



Jim and Mary co-chaired a major fundraising campaign for the Lincoln Children’s Museum and led the largest campaign since its founding for the Lincoln Children’s Zoo. In 2008, to recognize NEBCO’s 100th anniversary, the Abel Foundation made the largest gift ever received by the United Way of Lincoln/Lancaster County.

Jim’s leadership role in Vision 2015 helped develop Antelope Valley and led to the construction of Pinnacle Bank Arena, a public-private partnership with people working together for a common goal, paving the way for future collaborations.

Recent NEBCO projects that have enhanced Lincoln and Nebraska include Quarry Oaks, Fallbrook, and Haymarket Park, home of the Lincoln Saltdogs.

Jim and Mary’s goals with the Abel Foundation are to make things happen, to make a difference in the community and to help good projects get off the ground. Their work and their gifts have changed the face of Lincoln and have improved the community for generations to come. LCF is honored to recognize their good works with the 2016 Charity Award.

Use a Charitable IRA Rollover and Support Lincoln Forever

Finally, after years of last-minute extensions, Congress made the popular Charitable IRA rollover a permanent part of the tax code. The rules for making a qualified charitable distribution from an IRA have not changed—the donor must be at least 70 1/2, the gift must be made directly to a public charity and total charitable distributions must not exceed \$100,000 in each year.

While charitable IRA rollover distributions cannot be made to a donor advised fund, they are well-suited to create permanent endowed funds for Lincoln Community Foundation or the specific nonprofit organizations you wish to support. For example, charitable rollovers of at least \$10,000 can create a named Lincoln Forever Fund. These funds provide grantmaking dollars that are used to meet the ever-changing needs of Lincoln and also provide permanent recognition of a donor’s love for Lincoln.
